What is eBond?

eBond is a method for filing U.S. Customs bonds electronically. eBond is a part of the ACE development project, which is CBP's Automated Commercial Environment (ACE). ACE will replace CBP's Automated Commercial System(ACS) on November 1, 2015. eBond will be deployed on January 3, 2015, and will be required for all new continuous bonds and single transaction bonds where the entry is filed in ACE.

Our speaker, Terry Cummings from Roanoke Trade, will outline how this will impact you and explain the new process in filing bonds electronically. For those CHB's who will continue to file entries via ABI until November you will want to take advantage of the benefits eBond has to offer come January 3rd.
