Amanda Barlow, Director, Marketing, Carnet and Trade Services Department, United States Council for International Business will fill us in on the advantages of carnets. The ATA Carnet, commonly known as the Merchandise Passport, is an international customs document that permits duty-free and tax-free temporary import of your goods into 71 countries, thereby decreasing the cost of and increasing the return on doing business internationally. US Council for International Business (USCIB) is the National Guaranteeing Association, appointed by US Customs and Border Protection in 1969, to guarantee and run the system in the U.S. The one hour in-depth training covers all the ins and outs of how the ATA Carnet works and how to avoid and/or resolve problems.
