THE PROGRAM

We are honored to welcome our new Area Port Director of Portland, Mr. John Barnes, as our featured speaker this month. Mr. Barnes has served as the Area Port Director of Portland, OR since September 2014. In this capacity, he is responsible for directing and managing various enforcement-related programs that address anti-terrorism and border security in both the passenger and cargo environments.

Mr. Barnes began his career in 1987 working as an Import Specialist for the U.S. Customs Service at the Los Angeles International Airport. In 1991 he transferred to Blaine, WA as an Inspector, becoming a Senior Inspector in 1994. In Blaine he worked on the CET Team, as the Senior Cargo Inspector and as the NTEU President. Mr. Barnes then moved to South Florida as an A-TCET Supervisor for Port Everglades / Ft. Lauderdale Airport. In 2004 he became a Chief CBP Officer in the Seattle Seaport. He assumed the Assistant Port Director- Trade duties in the Area Port of Champlain, NY in 2009. He also served as the Assistant Port Director-Passenger in Champlain.
