Special Guest Speaker
Richard Read of The Oregonian

Richard Read, a two-time Pulitzer Prize winner, is a senior writer at The Oregonian, covering economics and international affairs. He has reported in more than 50 countries, ranging from North Korea and China to Afghanistan and Pakistan.

Rich writes about connections between Oregon and the world, recently covering the labor dispute at the Port of Portland. In 1998, he explained the Asian financial crisis by following a container of french fries from a Washington-state farm to a McDonald's in Singapore, and on to Indonesia as riots led to President Suharto's fall. In 2001, he and three other reporters exposed national abuses by U.S. immigration officials stemming from incidents at Portland International Airport.

Born in Scotland and raised in Boston, Rich attended Amherst College and later Harvard University on a Nieman fellowship. He was the first foreign correspondent for a Northwest newspaper, based in Tokyo for six years in the '80s and '90s after a stint in Thailand.
